

STATEMENT OF CLAIM

Plaintiff claims against the Defendants as follows:

- i) A declaration that the words complained of and published by the Defendants particularly: **that the winner of Miss Western, 2025 slept with Plaintiff and his team members to secure the crown; that #IsaacMensahisascam #scam #Pageant #viral #Scamalert, that "Kase Kaish ...Ex One Entertainment na big time Scamooo", and that "Miss Western and Ex One Entertainment are thieves"** are defamatory of the Plaintiff's character.
- ii) An order of the Honourable Court directed at the Defendants to publish an unqualified retraction and an apology on the TikTok mobile application platform and all other media platforms on which the impugned publication was made by the Defendants with the same prominence as the defamatory words received.
- iii) An order of the Honourable Court for perpetual injunction restraining the Defendants, their agents, assigns, servants and any person claiming authority from the Defendants herein from making any further publication and/or causing to be published, printed, distributed and/or circulated same and/or other similar defamatory words against the Plaintiff.
- iv) The sum of One Million Ghana Cedis (Gh¢1,000,000.00) as damages for defamation against the Defendants.
- v) Costs including Lawyer's fees.
- vi) Any other order(s) as this Honourable Court may deem fit.

STATEMENT OF CLAIM

1. The Plaintiff is a Ghanaian, an Entertainment Executive, an Entrepreneur and a talent manager with over fourteen (14) years of experience in building impactful platforms within Ghana's creative and entertainment industry.
2. The Plaintiff is also the founder and the Chief Executive Officer of Ex-One Entertainment, a sole proprietorship registered under the laws of Ghana.
3. The Plaintiff asserts that his commitment to youth development and the creative arts industry has earned him several recognitions including being honoured by YFM radio station as one of the YPower Icons – 30 Ghanaian Youth Driving Impact and Inspiring a Generation, awarded at the Western Gospel Awards (2025) in recognition of his significant contribution to the growth of the creative arts industry as well as being honoured by Shama Senior High School, Shama for his role in empowering young ladies.
4. The Plaintiff further avers that under his leadership, Ex-One Entertainment has grown into a respected event house known for producing high-quality entertainment experiences that intentionally blend youth empowerment, social impact and creative excellence and has become a prominent entertainment and events brand in Sekondi-Takoradi in the Western Region of Ghana.

5. With over fourteen (14) years of proven experience in the industry, Plaintiff avers that Ex-One Entertainment has established itself as a dynamic force in delivering impactful entertainment experiences that inspire, empower and connect audiences throughout Ghana.
6. The Plaintiff further avers that one of Ex-One Entertainment's successes in the entertainment industry is "Miss Western", a nationally celebrated beauty and empowerment brand launched in 2018 that has grown into one of Ghana's most prestigious pageants.
7. Further to paragraph 6 supra, the Plaintiff avers that this pageant helps young women build confidence, leadership and purpose while offering unmatched visibility and rewards, including a car for the winner each year and also serves as an effective marketing and social impact tool for companies looking to connect with their audience.
8. Plaintiff avers that Ex-One Entertainment also produces and organizes "X-Icons", a high-energy talent discovery and performance platform designed to identify, nurture and launch emerging stars across the country as well as "Western Radio and TV Personalities Awards" (WRTP Awards), a premium awards scheme that celebrates excellence, credibility and influence within the Western Region.
9. The Plaintiff will contend that 1st Defendant was a contestant in Ex-One Entertainment's Miss Western 2025 edition, where she placed 4th in the competition.
10. The Plaintiff further avers that 2nd Defendant was also a contestant in Ex-One Entertainment's Miss Western 2023 edition, where she placed 3rd position (2nd Runner up) in the competition and received her prize.
11. The Plaintiff asserts that in 2024, Plaintiff's Ex-One Entertainment as part of its quest to promote its contestants recruited 2nd Defendant to be a co-MC for the 2024 edition and an MC for "X-Icons", a music reality show organized by Plaintiff's Ex-One Entertainment.
12. Further to paragraph 11 supra, Plaintiff avers that 2nd Defendant was again recruited in 2025 to co-MC for Miss Western and after that recommended her for another show "Book Worm" which airs on GH One TV, Accra.
13. The Plaintiff avers that Defendants have made several false publications against him and his business, Ex-One Entertainment in a series of publications on TikTok.
14. The Plaintiff further avers that the said publication by the Defendants was replete with statements which are defamatory to the Plaintiff and his business, Ex-One Entertainment.

PARTICULARS OF DEFAMATION:

- i. That following the finale of Miss Western in August 2025, 1st Defendant took to her TikTok account, 'Queen Nuella', on 25th August, 2025 and in response to comments from a supporter of the winner, Esaaba, **claimed that the winner had**


slept with members of the organizing team, which includes the Plaintiff to secure the crown. A claim which is a complete falsehood.

- ii. That 1st Defendant on 16th January 2026, again took to her TikTok and posted a video with an on-video caption “ **#IsaacMensahisascam** and added the hash tags **#Scam #pageant #viral #scamalert**.
 - iii. That 1st Defendant on 17th January, 2026 again took to her TikTok and posted a video she captioned “**Kas3 kaish ...Ex One Entertainment na big time scam ooo**”.
 - iv. That on 17th and 18th of January, 2026, 2nd Defendant joined the TikTok live conversation hosted by 1st Defendant, where she made defamatory comments against Plaintiff saying that **Miss Western and Ex-One Entertainment are thieves**.
15. The Plaintiff avers that by reason of the Defendants’ popularity on social media, the Defendants have a considerable following on various social media platforms, especially on TikTok, where 1st Defendant has about Fourteen Thousand Two Hundred followers (14,200) while the 2nd Defendant also has about Nine Thousand, Three Hundred and Seventy-One followers on TikTok (9,371) as at the time the publication was made.
 16. The Plaintiff asserts that the words used by the Defendants against him created in the minds of people that the Plaintiff and his business, Ex-One Entertainment, are a scam, thieves, and a criminal organisation who are in the business of scamming young girls and the general public.
 17. The Plaintiff further avers that he has suffered serious damage to his character and reputation by being portrayed to right-thinking members of society as a criminal who runs a criminal organization and has no regard for the laws of Ghana.
 18. The Plaintiff avers that his business, Ex-One Entertainment, has suffered serious damage to its reputation by being portrayed to right-thinking members of society as a criminal organization that condones and benefits from scamming young girls and the general public.
 19. The Plaintiff further avers that he has suffered serious damage to his character and reputation by being portrayed to right-thinking members of society, and indeed people in the entertainment and creative industry as not being a person worthy of being entrusted with the offices he occupies in the entertainment industry and a distrustful member of society.
 20. The Plaintiff avers that the words used by the Defendants in their publications have caused right-thinking members of society to shun him and his business, Ex-One Entertainment.

21. Wherefore the Plaintiff claims against the Defendants as follow:

- i) A declaration that the words complained of and published by the Defendants particularly: **that the winner of Miss Western, 2025 slept with Plaintiff and his team members to secure the crown; that #IsaacMensahisascam #scam #Pageant #viral #Scamalert, that "Kase Kaish ...Ex One Entertainment na big time Scamooo", and that "Miss Western and Ex One Entertainment are thieves"** are defamatory of the Plaintiff's character.
- ii) An order of the Honourable Court directed at the Defendants to publish an unqualified retraction and an apology on the TikTok mobile application platform and all other media platforms on which the impugned publication was made by the Defendants with the same prominence as the defamatory words received.
- iii) An order of the Honourable Court for perpetual injunction restraining the Defendants, their agents, assigns, servants and any person claiming authority from the Defendants herein from making any further publication and/or causing to be published, printed, distributed and/or circulated same and/or other similar defamatory words against the Plaintiff.
- iv) The sum of One Million Ghana Cedis (Gh¢1,000,000.00) as damages for defamation against the Defendants.

- vi) Any other order(s) as this Honourable Court may deem fit.
